 Sealed bids must reach to the office of undersigned till 09.06.2023 up to 09:00 AM. Bids shall be opened on the same day at 10:00 AM in the office of Addl: Registrar, Chairman Procurement Committee in presence of the representative of the bidders (who may choose to be present).
